Since its foundation in 1983, the King Faisal Center for Research and Islamic Studies (KFCRIS) has been serving as a leading academic, intellectual, and cultural hub in the Kingdom of Saudi Arabia as well as the Arab and Muslim world. The KFCRIS produces original research in humanities and social sciences and provides a platform for local, regional, and global researchers and research organizations to engage in intellectual discussions and cultural dialogues.

Through its publication arm, Al-Faisal Cultural House, the KFCRIS also publishes books and periodicals that deal with themes and topics important to the Kingdom, Arab and Muslim societies, and the world. Moreover, it stores historical and modern knowledge through its library and preserves the memories of the late King Faisal and his family through its Faisal Family Archives. Furthermore, its museum promotes the value of Islamic manuscripts and art collections.

By all accounts, 2020 was a unique year that affected humankind due to the coronavirus pandemic. The Kingdom saw its share of casualties which left serious after-effects on the economy and all aspects of life. Much of our social, cultural, educational, commercial and financial activities moved online.

One of the most important “migrations” was the G20 Summit, where global leaders gathered through virtual means to discuss socio-economic plans. The Riyadh Summit, which was the first such event hosted in the Middle East, dealt with both the consequences of the pandemic and appropriate solutions to restart stagnant economies.

The King Faisal Center for Research and Islamic Studies (KFCRIS) played a key role in the preparations for the G20 Summit, along with the King Abdullah Petroleum Studies and Research Center (KAPSARC), as the two institutions were entrusted with the convening of the Think20 (T20) Engagement Group—the think-tank forum that prepares policy recommendations to Summiteers. Despite serious logistical challenges, the KFCRIS team members upheld their scholarly reputations and strengthened our status as one of the region’s most respected research institutions. Importantly, the G20 gave the Kingdom the opportunity to expound the progress

that has been achieved through the economic and social initiatives being implemented as part of Saudi Vision 2030, to which the KFCRIS is proud to have made some modest contributions. Equally importantly, the KFCRIS strengthened collaborative relationships with dozens of research bodies around the world.

In addition to high-profile events, the primary focus of the KFCRIS remains the production of original academic research. Our commitment to research excellence is steadfast and the KFCRIS researchers generated scores of publications on a variety of topics, including language, culture, and social and political concerns. These are available in both Arabic and English so that students and researchers around the world may benefit from them. The KFCRIS also hosted a full program of seminars, public lectures, and panel discussions with the participation of leading thinkers from around the world, as well as hosting regular exhibitions of Islamic arts. Despite various challenges throughout 2020, the KFCRIS held many cooperative activities with leading global research centers, universities, and think-tanks, all of which will continue. Doing so accomplishes intrinsic goals, namely to enrich Saudi cultural and intellectual life and keep us dedicated to fulfilling our Arab and Muslim responsibilities.

The KFCRIS stands as a beacon of understanding and learning in a part of the world that is changing fast and for the better. Our role is to promote independent, high-quality research that has a genuine impact on public policy, which occurs because of a first-rate team of scholars, researchers, and curators, along with superlative support staff, whose contributions are vital. If the KFCRIS fulfils its mission, it is largely because of their dedication and eagerness to add value, for which we are deeply grateful.

Exceptional Year and Resolution for Excellence

It was the final year of its Five-Year Strategic Goals 2016–20. In 2020, the Center also hosted the T2o, one of the Engagement Groups of the G2o Saudi Arabia, with the King Abdullah Petroleum Studies and Research Center (KAPSARC)—which was a great success, with the two-day T2o Summit being attended by 2,805 participants online.

In 2020, the Center also made significant progress in its research activities. Two new research units, the Cultural Studies Unit and the Socioeconomics Unit, were created. The African Studies Unit launched a new edited monthly report, *Africa Followups*. The Asian Studies Unit edited a special issue of the *Asian Journal of Middle Eastern and Islamic Studies* on Saudi Arabia–China relations. Throughout the year, the Center hosted and co-hosted 37 research events, and published a number of research papers, including eight *Dirasat* (KFCRIS Papers), one *Qira'at* (KFCRIS Humanities Papers), 14 Special Reports, 20 Commentaries, two Policy Briefs, and eight special weekly reports on the regional and international impacts of the COVID-19 pandemic.

The Center's publishing arm, the Al-Faisal Cultural House, published seven books in total in 2020, and continued issuing the *Journal of Linguistic Studies* and the *Al-Faisal Magazine*. Moreover, it began

to publish the bi-lingual *International Journal of Humanitarian Studies* for the King Salman Humanitarian Aid and Relief Center, whose first two issues were published in 2020. The Faisal Family Archives continued to collect resources in relation to King Faisal and his family, and provided materials to external entities, including King Faisal's interview on his 50-year vision, which was aired by Saudi Arabian Airline (SAUDIA) on the occasion of the Saudi National Day. In 2020, the Center also substantially improved its infrastructure and raised its quality. In particular, its library completed a transfer of its database to the open-source Koha integrated library system; its museum also set up a new laboratory for conserving the Center's manuscripts and collections.

The Center's administrative departments have also done excellent jobs in supporting its intellectual and cultural activities. Following the outbreak of the pandemic, its Administration and Finance Department, Public Relations Department, and Project Department worked hard to shift the Center's activities to online platforms, enabling the Center to function seamlessly despite the lockdown between March and May and the new coronavirus-related workplace regulations. Since its post-lockdown reopening, the Center has been following the guidelines

supplied by the Ministry of Health and the Ministry of Human Resources and Social Development strictly, and practicing vital precautionary and health monitoring measures to contain the spread of the virus.

I send my deepest gratitude to all members of the Center and also encourage them to continue working hard to achieve the Center's vision of becoming a global wellspring of knowledge.

The Outbreak of the Coronavirus/COVID-19 Pandemic: The Precautionary Measures Taken by the KFCRIS

The year 2020 is remembered for the outbreak of the global pandemic with a new type of coronavirus, COVID-19, which took the lives of over 1.5 million by the end of the year. In the Kingdom of Saudi Arabia, the first case of COVID-19 was confirmed in Qatif on March 2. Understanding the danger of the new virus to its citizens and residents, the Kingdom's leadership acted swiftly, announcing the precautionary measures required for containing the spread of the virus. The KFCRIS implemented several precautionary measures accordingly. All events were postponed and in-person training courses for employees were canceled. In addition, the method of checking in and out by the Center's employees with their fingerprint was stopped and only the access card was used. These procedures followed the guidelines for preventing the spread of the COVID-19 in the workplace provided by the Ministry of Human Resources and Social Development (MHRSD). Moreover, based on the principle "prevention is better than cure," the KFCRIS also produced a manual that included the Ministry of Health's instructions to raise awareness about safety and precautionary measures, and regularly sent awareness messages to employees. Furthermore, the administrative committee was formed to monitor infected employees, apply isolation measures, trace their contacting record, and follow up on their health status.

The KFCRIS was one of the first organizations in the Kingdom to announce the suspension of employees' attendance at the workplace before the official lockdown. The Center's IT staff deployed programs to enable the employees to carry out their work remotely and trained them on using



these programs; it also prepared applications that enabled them to conduct necessary meetings online. Even with social distancing and the applied restrictions, the KFCRIS continued to convene research events, hosting them remotely and streaming on social media: 30 virtual events took place between April and December. By the time the MHRSD announced the lifting of the suspension of workplace attendance and the temporary reduction in the number of workers attending, the KFCRIS swiftly followed and implemented percentage-based attendance instructions advised by the Ministry. All building facilities were sanitized, sanitary tools such as masks, sanitizers, and disposable gloves

were prepared, and the employees' commitment to the precautionary measures was monitored. Furthermore, as the KFCRIS was concerned with the impact of the pandemic on a variety of aspects such as the economy, politics, security, culture, and education, it issued eight weekly reports about the national, regional, and global repercussions of COVID-19 (p. 28), and also held several panel discussions on this topic (pp. 35–36).

The T2o (Think 2o)

Co-Hosted by the KFCRIS and the King Abdullah Petroleum Studies and Research Center (KAPSARC)



The T2o (Think2o) is one of the Engagement Groups of the G2o, and is a network of research institutes and think-tanks from the G2o countries that serves as an “ideas bank” for the G2o. It assembles Policy Briefs from global experts and provides evidence-based policy recommendations to the G2o leaderships through the T2o Communiqué. As the Kingdom of Saudi Arabia hosted the G2o in 2020, the King Faisal Center for Research and Islamic Studies (KFCRIS) and the King Abdullah Petroleum Studies and Research Center (KAPSARC) were appointed by royal decree to co-host the Saudi T2o. The KFCRIS’s involvement in the T2o began with sending a delegation to the Japanese T2o Summit in May 2019. Following the appointment in September 2019, the KFCRIS and the KAPSARC worked on the preparation for the Saudi T2o Summit, which took place on October 31 and November 1, 2020, by building a highly professional team to co-lead the initiative and appointing co-chairs of each Task Force.

Five Main Themes and Objectives of the Saudi T20

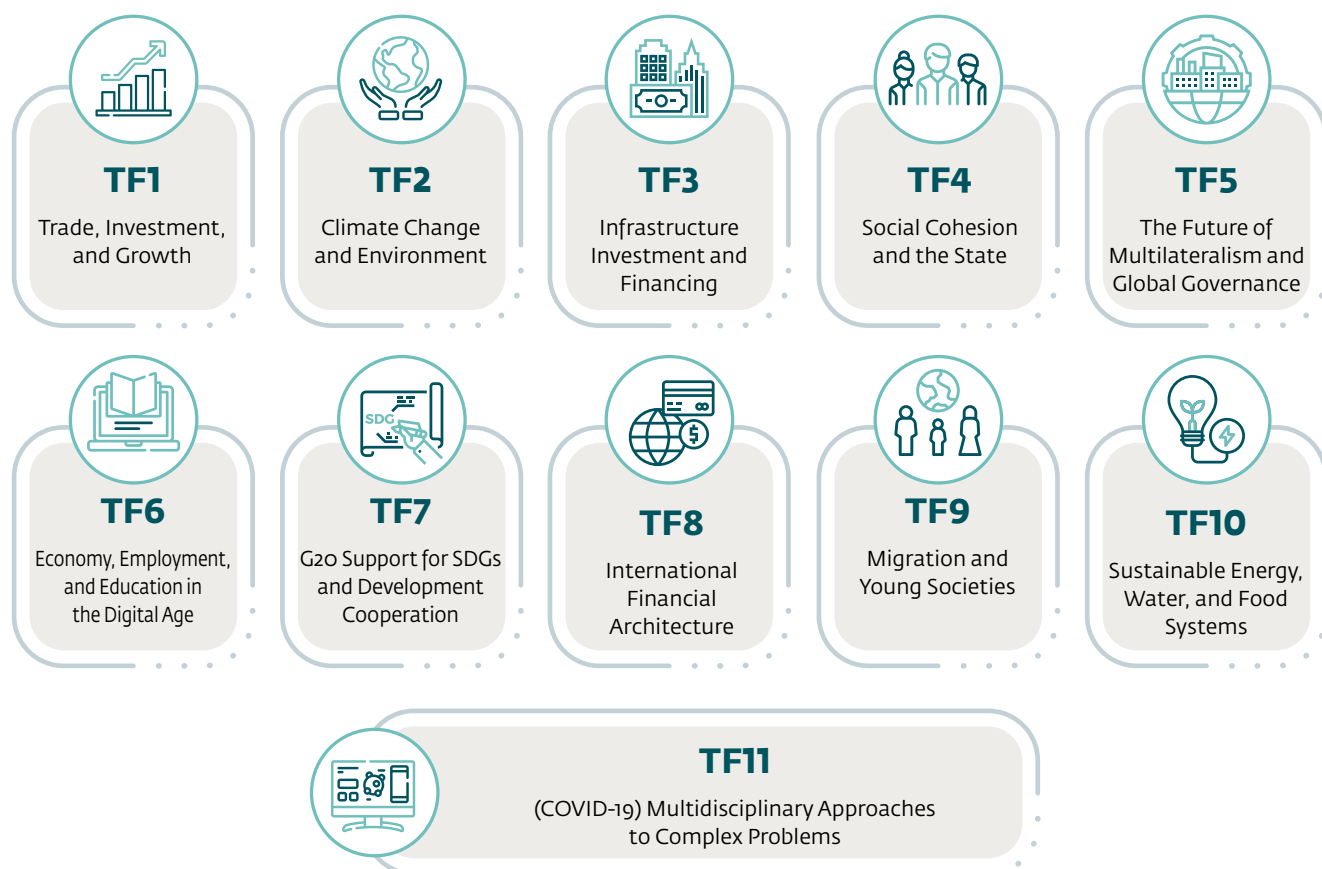

Eleven Task Forces of the Saudi T20

The Saudi T20 initially established 10 Task Forces. In response to the outbreak of the global COVID-19 pandemic, the T20 created the additional 11th Task Force to develop policy recommendations for effectively facilitating a transition to a post-pandemic reconstruction.

Among these 11 Task Forces, the KFCRIS oversaw the work of five Task Forces, which produced 49 Policy Briefs in total, out of 146. These Policy Briefs went through a rigorous three-stage external review process following a thorough internal review before moving to the final editorial process.

This Task Force discussed the following issues: creating innovative policies and programs to encourage cross-generational engagement; providing skills and opportunities for youth; youth unemployment; demographic changes; economic growth and the reform of social systems; labor market integration and social inclusion for migrants; providing access and education opportunities for migrant and refugee children; encouraging and supporting high-skilled migration; and improving evidence-based research on the social, political and economic impacts of migrants.

Key Events of the Saudi T2o

Inception Meeting

The Inception Meeting, which took place in Riyadh on January 19 and 20, 2020, was attended by over 550 people from 64 countries. With those who participated virtually, the total number of participants surpassed 1,200, and the number of participating think-tanks was over 150.



Webinars and the Virtual Conference

While the global situation affected by the COVID-19 pandemic put a halt to many of the in-person events, the T2o team managed to move the discussions to online platforms smoothly, hosting many Task Force members-only workshops as well as open online webinars for the larger T2o audience. Moreover, throughout the months of May and June, the Task Forces held members-only workshops to discuss the effects of COVID-19 on the overall policy world. This was followed by a three-day conference held virtually on June 15–17, which was entitled "Policy Recommendations for a Post-COVID-19 World." The list of speakers included high-level officials, such as HRH Abdulaziz bin Salman Al Saud, Saudi Arabia's Minister of Energy, and Dr Tedros Ghebreyesus, the Director-General of the World Health Organization.

Summit Season

Due to the suspension of travel and mass gatherings, the T2o continued to hold its discussions in virtual settings. To compensate for the lack of the "in-person" dimension, the T2o created the six-week-long Summit Season, which took place from September 17 through November 1. During the Summit Season, each Task Force held a webinar co-hosted by an international institute as a way to build bridges with various research institutes across the world. Each webinar offered thematic discussions, with Task Force members presenting their insights on them and inviting a keynote speaker as well as an artist's presentation. Prior to each webinar, the Policy Briefs of each Task Force were released on the T2o website for the wider audience to read, enabling them to join the webinar conversations, which were open to the public.

The T2o Summit

The T2o Summit took place virtually as a two-day event on October 31 and November 1, 2020. It gathered world-leading thinkers, researchers, and policy-makers, and provided them with an interactive platform to discuss evidence-based policy recommendations and matters of global importance. A highlight of the event was the formal handover of the T2o Communiqué to Saudi Arabia's Minister of Foreign Affairs Prince Faisal bin Farhan Al Saud, who represented the Custodian of the two Holy Mosques King Salman bin Abdulaziz Al Saud at the ceremony. The keynote speech was delivered by HRH Prince Turki AlFaisal, the Chairman of the Board of the KFCRIS. In total, 2,805 users were connected to the T2o online platform during the two-day Summit.

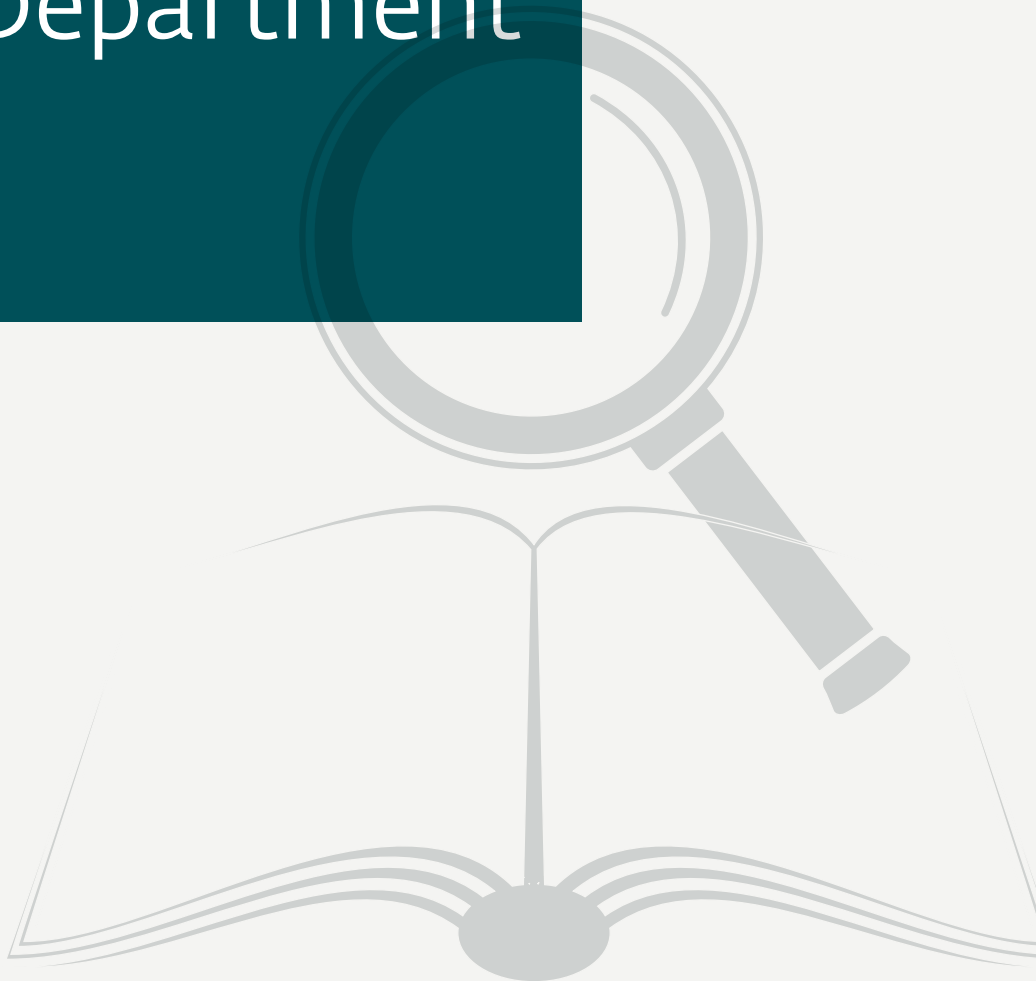

Research Department



Research Units

The KFCRIS conducts in-house research and attracts contributions from external researchers. At the end of 2020, it was host to four research units: Cultural Studies, Socioeconomics, African Studies, and Asian Studies. The Cultural Studies Unit is a new unit established in 2020, while the Socioeconomics Unit was converted from the Political Economy Unit in the same year. The Security Studies Unit, which had existed since 2018, ended its duties in March 2020.

Cultural Studies Unit

The Cultural Studies Unit advances research that focuses on culture and cultural policies and the way they interact with broader social and political contexts. It adopts a broad definition of culture that includes identity, discourses, and cultural practices as well as creative cultural production. It aims to contribute to a deeper understanding of cultural change at the local, regional, and global levels, and to raise the quality of public debates concerning cultural policies. The Unit is currently focusing on its work for the Ministry of Culture's "Report on the State of Culture in the Kingdom of Saudi Arabia" project.



Socioeconomics Unit

The Socioeconomics Unit highlights the development of contemporary socioeconomic issues, concepts, and theories. In addition, it aims to study the significance of socioeconomic issues on specific societies and/or constituencies, with emphasis on Saudi Arabia, the Gulf states and the wider Arab and Muslim worlds. The Unit encourages interdisciplinary approaches, encompassing socioeconomic, sociopolitical, and sociocultural topics and issues in order to provide a broader picture as well as a nuanced analysis of the questions arising from the intersection between economies and societies.



African Studies Unit

The African Studies Unit specializes in affairs in the African continent. The Unit examines political, strategic, cultural, economic, and social issues by bringing together multiple specializations and analyzing domestic dynamics and intra-regional relations. In 2020, the Unit launched *Africa Followups*, an edited monthly report that, through multidisciplinary approaches and perspectives, discusses political, economic, and security issues in the African continent, issues of interest to those in and from the continent, and their regional and international implications.



Asian Studies Unit

The Asian Studies Unit is dedicated to the study of Asia and Asian societies. As one of the regionally-specialized units, it aims to promote greater understanding of Asia within the Gulf and the wider Arab world. It also seeks to enhance the quality of academic, journalistic, and policy-making coverage and discussions surrounding Asia and its complex relationships with Saudi Arabia and the broader Middle East (alternatively identified as West Asia). It is also intended to build connections with other Asia-focused research institutions and think-tanks around the world.



In addition to the above research units, the KFCRIS hosts the Policy Initiative, which conducts independent policy-oriented research. In 2020, the Policy Initiative focused on two themes in particular: (i) education-to-employment transition; and (ii) tourism and local development. It delivered its papers and policy recommendations to multiple government entities, including the Ministry of Education, the Ministry of Human Resources and Social Development, the Human Resources Development Fund, the Ministry of Tourism, the Ministry of Culture, and the Ministry of Municipal and Rural Affairs.

In 2020, many KFCRIS researchers also worked on the T20 with the KAPSARC.

Researchers

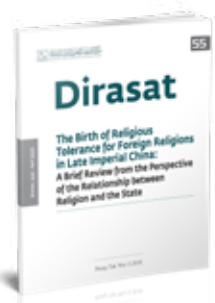

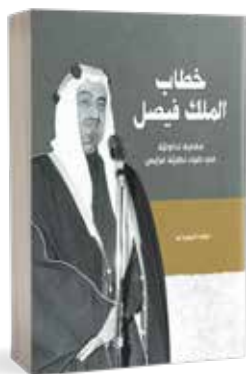

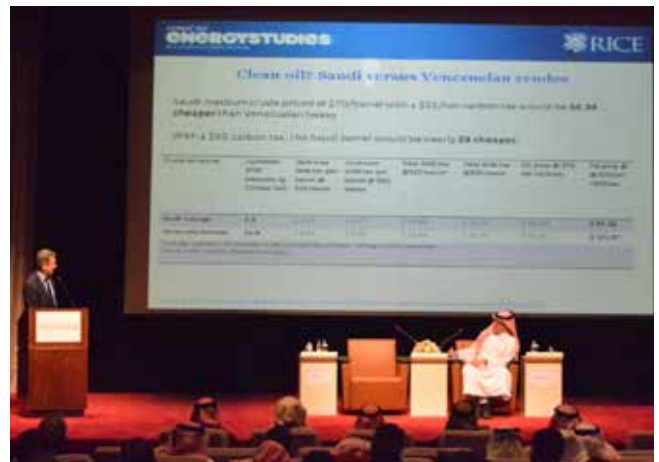
Research Events

The KFCRIS Library provides a variety of services to researchers, ranging from surveying information and obtaining sources and references to providing official statements (i.e., investigating and notifying whether certain topics have previously been studied) and depositing university theses and issuing the certificate for that deposit. The following table summarizes the services the library provided to researchers in 2020:

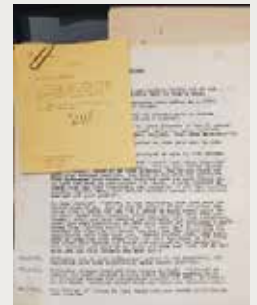
In 2020, the Faisal Family Archives (Darat Al Faisal) received more than 140 documents in multiple languages. All of them were restored and sterilized before being indexed. The archives also received and scanned almost 2,000 photographs of King Faisal and his sons, especially Prince Abdulrahman, Prince Bandar, and Prince Turki. The total number of photographs now owned by the archives is 20,719. Moreover, 63 audiovisual materials related to King Faisal were transcribed and indexed. Furthermore, the archives cataloged magazines—all

local, Arab, and foreign—containing news about and photographs of King Faisal and his family. The number of catalogued magazines exceeded 1,400.

The Archives also provided materials to entities such as the King Abdulaziz Foundation for Research and Archives (Darah), the Taif University, and MBC. In addition, it provided a video of King Faisal's interview with CBS to Rush Films, in which the King shared his vision about the Kingdom for the following half century. The video was included in SAUDIA's movie for the Saudi National Day. Moreover, it provided individual researchers with their requested materials.



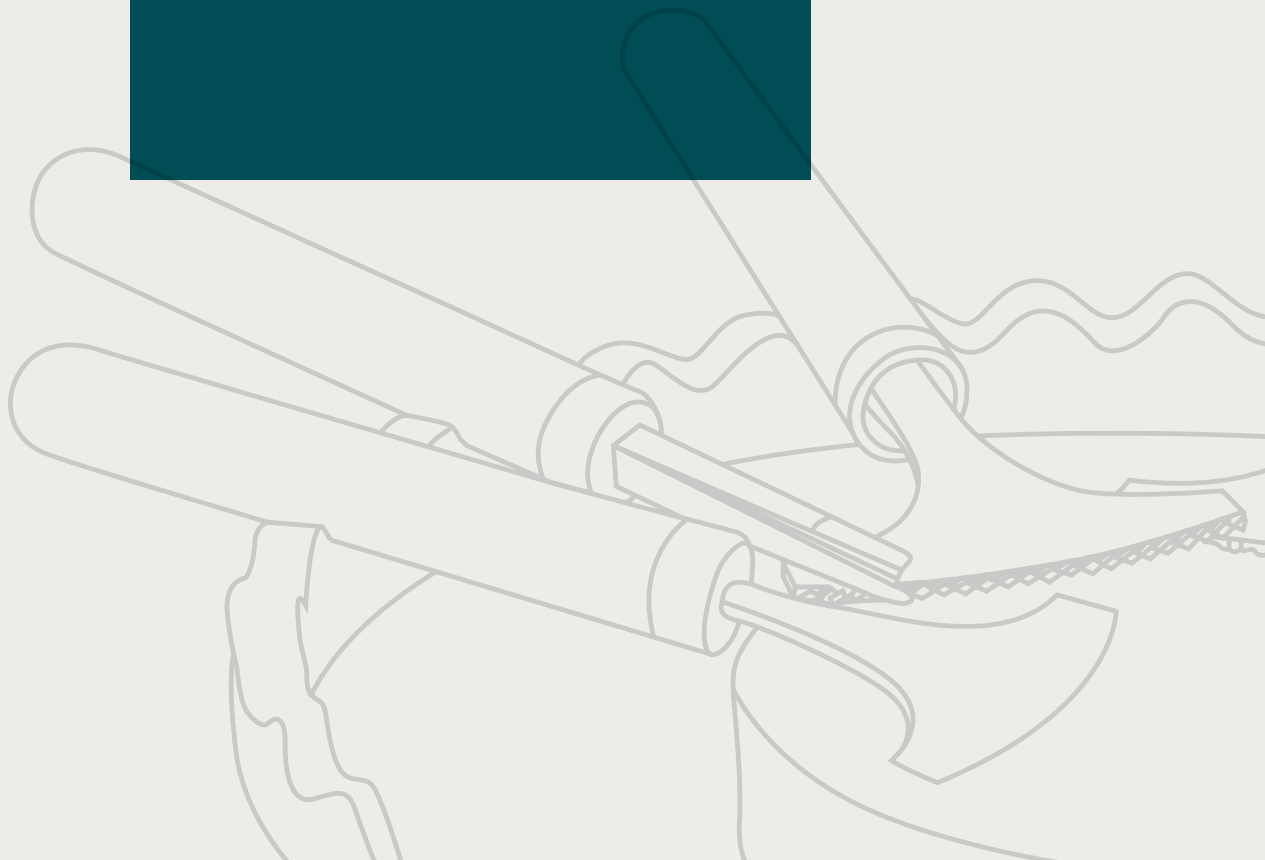

Museum



Museum

Due to the COVID-19 pandemic, the KFCRIS Museum had to reschedule its new exhibition "FAISAL: A Life at the Heart of the 20th Century," which had been planned to take place in Paris in 2020. Nevertheless, it gave the museum time to focus on the improvement of its infrastructure, including the setting up of the new laboratory for manuscripts and collections conservation.



Major Achievements in 2020

Conservation

The new integral laboratory began to help the museum maintain its unique and special artifacts by offering various modern tools and equipment that enable conservation experts to achieve their highest possible quality work.

In 2020:

- 13 manuscripts, 14 pages of various manuscripts from the Wahj Gallery, and six external documents were restored
- Reports that assess the condition of 49 manuscripts were prepared



Sterilization

Sterilization is the first stage of preserving artifacts by killing insects and fungi on manuscript papers and leather covers. These insects and fungi can cause significant damage to manuscript papers and transfer this damage to intact adjacent papers.

In 2020:

- 106 manuscripts, 12 museum pieces, 17 books, 131 documents, five photographs, and two booklets were sterilized

Archiving

Archiving is conducted based on the numbering system for museum collections and the description cards system in line with the international guidelines and standards of the International Council of Museums.

In 2020:

- 150 audio materials were archived
- 583 Islamic art collections were registered into the archival system



Binding

Binding is one of the technical procedures for preserving manuscripts after treatment and conservation. The museum binds manuscripts and re-binds books with natural leather and gold engravings.

In 2020:

- 85 Islamic manuscripts were bound



Managing the Storage

The museum has been working on transferring its storage facilities to store all museum pieces in one place and ensure appropriate environmental conditions as well as easy access.

In 2020:

- The collections facility was repaired and renovated
- The King Faisal Memorial Collection was relocated
- 260 cases were made to preserve artifacts from the Islamic Art Collection in their best status
- 100 cases were made to preserve the audiotapes from the Saudi Memory Unit



Inventorying

Inventorying is the museum's regular process to maintain its pieces.

In 2020:

- Various museum collections were inventoried: (1) Arab-Islamic Art Collection; (2) King Faisal Memorial Collection; (3) Coins and Currencies Collection; (4) Queen Effat Coins Collection; (5) Fine Art Collections etc.
- The KFCRIS History Collection was prepared through listing available materials
- The item descriptions for the Islamic Art Collection were revised
